The Ministry of Public Works and Housing (MPWH) through the Special Procurement Committee (SPC), invites the specialized company, to submit proposals for the prequalification request for the Design, Build, and Operate a Weight in Motion (WIM) System for axial loads at Al-Quwayrah Weigh Station Special Tender No.: (1/2026/WIM/RFQ).

1) Project Description:

The project involves the design, construction, installation, and operation of a Weigh-in-Motion (WIM) system at al- Quwayrah weighting station for a period of 3 years contract (construction and operation). The main objective is to monitor and control overloaded vehicles in real-time without disrupting traffic flow. The system will be embedded in the road to measure the transient forces exerted by vehicle tires as they pass over the sensor. It will target vehicles exceeding 21 tons and operating within a speed range of 0–120 km/h or more.

- 5) The Prospective Bidder shall prepare and submit one (1) printed original, two (2) printed copies and one (1) electronic copy (on USB drive) of the complete Prequalification Application (clearly marking each one as "ORIGINAL", "COPY NO.1", "COPY NO.2", "ELECTRONIC COPY", etc. as appropriate). In the event of any discrepancy between the printed original and any printed copy or the electronic copy, the printed original shall prevail and be considered binding. Prospective Bidders shall not submit their Prequalification Application by e-mail.
- 6) The consultant will be evaluated according to the forms of evaluation in the tenders documents.
- 7) Offers shall be deposited in MPWH building (SPC) hall 6th floor, not later than **12:00 noon (Amman local time) 26/2/2026**, late tenders will be rejected and returned unopened.
- 8) Offers will be publicly opened **at 1:00 p.m. the same day**.
- 9) The Special Procurement Committee (SPC), the MPWH has the right to cancel the bid without stating the reasons and without thereby incurring any liability to bidders.
- 10) You are not allowed to submit an alternative offer, otherwise the tender offer will be rejected.
